This Licence Renewal is being granted in terms of regulation 6 (2) of the Gaming Authorisations Regulations (S.L. 583.05) (the 'Regulations'), issued under the Gaming Act (Chapter 583 of the Laws of Malta) (the 'Act'), by the Malta Gaming Authority (the 'Authority').

#### TERMS AND CONDITIONS

- (i) This Critical Gaming Supply Licence Renewal shall come into effect on 6 March 2023 (the 'Effective Date').
- (ii) This Critical Gaming Supply Licence is hereby being renewed by the Authority for a ten (10) year term (the 'Licence Term'), unless otherwise revoked, cancelled, or terminated, which term shall commence to run as of the Effective Date.
- (iii) This Licence Renewal is being granted subject to the provisions of the Act and all applicable regulatory instruments, as well as any other law which may be applicable from time to time.
- (iv) Upon expiration, this Licence may be renewed by the Authority for further ten (10) year periods, subject to the Licensee's continued compliance with the provisions of the Act, all applicable regulatory instruments, and all other applicable laws.
- (v) A request for the renewal of a licence shall be made within the timeframe prescribed by the Authority in any binding instrument, or in terms of any prescribed procedures or forms published by the Authority.
- (vi) The Licensee shall offer the critical gaming supply solely to persons or entities that are licensed by the Authority or the competent regulator in another jurisdiction within the EU or EEA, or in another reputable jurisdiction where the Authority has an agreement with the relevant regulator. The Licensee may also offer the critical gaming supply to persons or entities licensed by the competent regulator in another reputable jurisdiction, where the Licensee has justifiable reasons to be satisfied that the person or entity to which it is providing its critical gaming supply is subject to regulatory safeguards and supervision which are comparable to those of the Authority, such that the Licensee's integrity shall not be compromised.
- (vii) Further conditions are attached to this Licence document marked as Annex A, Annex B and Annex C.

## Annex A

### PLAY'N GO MALTA LIMITED - MGA/B2B/225/2012

The contracts must adhere to the requirements envisaged in the Gaming Authorisations and Compliance Directive (Directive 3 of 2018) and any other applicable law.
- c) The Licensee shall comply with the directions as specified within the letter issued with this Licence.
